## **UNIVERSAL CREDIT**

Shettleston Jobcentre is now a full service jobcentre for Universal Credit. This means that certain changes of circumstance will trigger a claim for Universal Credit for Gardeen tenants.

There are lots of different rules for when tenants are moved onto Universal Credit so please get in touch with Lyndsay or John who will assist you and refer you to a welfare rights adviser if required.

### BUDGET SETTING 2019-20

#### BUSINESS PLAN 2019-20

Gardeen's Management Committee has to agree a budget for 2019-20 to help plan for the business needs of the Association. This has been a challenging exercise as we have to look at all the costs and income. We want to provide a reliable, local service and offer a fair affordable rent.

This is difficult for the Management Committee as we are facing increasing costs, Universal Credit, cuts to Council services and financial uncertainties. We will finalise the Budget in February 2019. If you would like a copy of the document then please contact the office.

#### CHANGES TO YOUR SCOTTISH SECURE TENANCY RIGHTS

The Housing (Scotland) Act 2014 introduces a number of significant changes to the rights you have under the terms of your tenancy agreement.

The main changes relate to:

- Short Scottish Secure Tenancies;
- Assignation/Sub-letting/Joint Tenancies;
- Succession to Scottish Secure Tenancy;
- Change to eviction grounds when crime has been committed in the tenancy;
- Changes to eviction grounds for properties designed for special needs;
- Allocations;
- Ownership of property by applicant;
- Minimum length of time for application to remain in force.

Please contact Lyndsay or John if you would like to discuss these changes in more detail. A full update will be included in the Spring 2019 newsletter. Gardeen staff and Committee have been discussing the new Business Plan for 2019-20. Increasing costs, Universal Credit and financial uncertainties are challenges that the Association will face. We are looking to work closely with other partners in Greater Easterhouse to provide services that you need.

We will finalise the Business Plan shortly and this document will be sent to our lenders who monitor our performance.

## **ENERGY EFFICIENCY FOR SOCIAL HOUSING (EESSH)**

The Energy Efficiency Standard for Social Housing (EESSH) aims to improve the energy efficiency of social housing in Scotland. It will help to reduce energy consumption, fuel poverty and the emission of greenhouse gases. Gardeen have confirmed that all Association stock meets the standard to comply with the EESSH.

A Scottish Government consultation to set further energy efficiency standards for social housing closed in July 2018. We will provide a further update in 2019.

## **RENT INCREASE 2019**

You will receive some information from the Association in January 2019 on the proposed rent increase for 2019-20. By law, we are required to consult with you on the proposals.

The Management Committee are made up of local residents and they look at the budget for 2019-20 and the plans that have been made to ensure that your home is maintained and that you continue to receive a quality service.

All the costs for the Association are considered including staffing costs, training costs, repairs and maintenance costs and this helps us to budget for next year. The Management Committee also look at the long term financial plans for the Association to check that we have enough funds for our future proposals. We want to ensure that rents remain affordable but we must also ensure that we are covering our costs. Previously rent increases had been agreed using CPI inflation + 1.5%. CPI inflation is 2.4% at September 2018 and 2.4% at October 2018.

The proposed rent increase is 3.5% or 3.9%. The table below shows how much more, on average, tenants would have to pay per week by property size.

### ADDITIONAL SMOKE ALARMS

The Scottish Government proposed in 2018 that the Housing (Scotland) Act 1987 would be amended to reflect the following new requirements:

- at least one smoke alarm installed in the room most frequently used for general day time living purposes;
- at least one smoke alarm on every floor;
- at least one heat alarm installed in every kitchen;
- all alarms should be ceiling mounted and interlinked.

The Scottish Government has now confirmed that all housing associations must comply with these new requirements by February 2021.

## **LEGIONELLA**

The risk of contracting legionella in your home is very low but here are some simple steps that you should take to help protect you and those in your home:

- Turn your shower on and run for a few minutes at least once a week, preferably more often than this, to flush out stale water;
- Dismantle, scrub and de-scale your shower heads and shower hoses at least once every 3 months;
- Turn on every hot and cold water tap throughout your home at least once a week and let the water run for a short time.

## **CLOSE DOOR VANDALISM**

Over the last few months the Association has noticed an increase in vandalism to front close doors, where we have had to replace the lock keeper. When the lock keeper is broken it means that the close door can just be pushed open and is not secure. These repairs have cost the Association £3,189.25 from 1st April 2018.

If any resident does not have a key for the front door or requires extra keys for other members of their households, please contact our office and we can arrange keys for you free of charge.

Please speak to all members of your household and to visitors to your home and ask them to make sure that they either use a key to get into the close, or they wait to be buzzed in to the building. Under no circumstances should the door be pulled open with force.

## FIRE SAFETY THIS CHRISTMAS

Christmas is a time of excitement, hanging decorations, and putting up the tree but it is also a time when there is an increased chance of a house fire.

Follow these safety tips to help prevent fire in your home this Christmas:

- Check your Christmas tree lights carry the British Safety Standard sign;
- Always turn your Christmas tree lights off when you leave your home or when you are going to bed;
- Never place candles near your Christmas tree and never leave them unattended;
- Don't leave your cooker unattended when cooking;
- Don't attach decorations to heaters or lights;
- Don't overload electrical sockets.

#### Gritting

Glasgow City Council is responsible for gritting the roads and pavements. To report a gritting issue please call them on 0141 276 7000 (landline) or 0800 373 635 (mobile) .

If you have your own garden or a shared garden as part of a cottage flat or four in a block then you are responsible for gritting this area.

Gardeen regularly monitors the level of salt in the grit bins in our area but if a refill is needed then please go online to Glasgow City Council's website or call the numbers above.

#### **Travel Plans**

Check the weather forecast in advance. For up to date information regarding disruption to public transport please call 0871 200 22 33 or go to the Traveline Scotland website: www.travelinescotland.com.

If there is a red weather warning then our office will close and provide an emergency service.

#### **Prevent Freezing Pipes**

During a cold spell, keep your heating on at a low temperature. It could help prevent pipes freezing. Find out where the stopcock is at your property. If you are unsure please contact a member of staff who will assist you to find out where it is. Please also consider home contents insurance. Staff can signpost you to providers.

#### Keep Yourself Fit and Healthy

Check if you are eligible for a free flu vaccination. You may be eligible if you are over 65; are pregnant; if you have an existing health condition or if you work in healthcare. Many pharmacies offer the flu jab for a small fee if you are not eligible to have it for free. For further advice call NHS Inform on 0800 22 44 88.

## **AFFORDABLE WARMTH DIVIDEND**

The Affordable Warmth Dividend is a  $\pm 100$  payment made by the Council to Glasgow residents who are 80 years of age and older on or before 31 March 2019 to help keep warm during the winter.

If you received a payment last year then you will automatically receive a payment again this year. You will be sent a letter advising you when your payment will be made. **You do not need to re-apply.**

## **RENT PAYMENTS**

If you are experiencing difficulty paying your rent or meeting other household bills, then please contact us. Discussing any financial difficulties sooner, rather than later, will allow us to work with you to resolve matters.

Our Welfare Rights service (available at our office on a Wednesday morning and Friday afternoon) can also assist you to ensure you are receiving the welfare benefits you are entitled to and provide you with confidential advice and support for any money or debt worries you may have.

Our office will be closed from 1.00pm on 24th December 2018 until 9.30am on Friday 4th January 2019. Rent payments can't be taken at our office during this period but you are still able to make payments by Direct Debit; using your Allpay card or online using www.allpayments.net.
